This Contract for services is entered between _____ (Purchaser) and SEQUOYAH ENTERTAINMENT.

- ____ - The fee agreed upon is _____ and can be paid with a personal check, card or cash. Credit and debit cards can be used at a rate 2%. There is a service fee of \$50.00 for returned checks.

- ____ - All Payments are non-refundable under any condition. SEQUOYAH ENTERTAINMENT reserves the right to release unpaid reservations.

- ____ - I, Purchaser, understand that the event will START at: ____ and END at: _____. SEQUOYAH ENTERTAINMENT shall have access to the event facility AT LEAST 3 HOURS prior to the music start time to set up and test equipment.

- ____ - Purchaser/Venue shall provide access to TWO NEARBY ELECTRICAL OUTLETS. If the event is outdoors, the purchaser will be required to provide power access and shelter for SEQUOYAH ENTERTAINMENT staff and equipment.

- ____ - SEQUOYAH ENTERTAINMENT shall execute this contract as an independent contractor and not as an employee of purchaser.

- ____ - Purchaser is responsible for ANY and ALL damages resulting from the conduct of any and all persons attending the event with the exception of SEQUOYAH ENTERTAINMENT staff.

- ____ - Purchaser expressly reserves the right to control the manner, means and details of the performance by SEQUOYAH ENTERTAINMENT. SEQUOYAH ENTERTAINMENT will attempt to play Purchaser and guest's music requests but shall not be held responsible if certain selections are unavailable.

- ____ - SEQUOYAH ENTERTAINMENT shall make all reasonable efforts to perform in accordance with the terms of this agreement. However, if SEQUOYAH ENTERTAINMENT is unable to perform on agreed date of event, such inability will NOT be deemed to be breach of this agreement if caused by: sickness, accident, riot, theft, strikes, epidemics, Acts of God, or any other legitimate conditions beyond the control of SEQUOYAH ENTERTAINMENT. If such circumstances should arise, SEQUOYAH ENTERTAINMENT will notify the Purchaser and attempt to make all reasonable efforts to find a replacement. If unable to find a replacement, the Purchaser will receive a full refund and SEQUOYAH ENTERTAINMENT shall be relieved from further obligations under the terms of the within agreement. The parties will not constitute a breach of agreement and no damages will be deemed to arise there from.

- ____ - SEQUOYAH ENTERTAINMENT is not liable for any types of inclement weather, which would prevent any or all duties such as thunderstorms, tornadoes, floods, snow, etc.).

- ____ - Purchaser is responsible for shelter of SEQUOYAH ENTERTAINMENT staff and equipment.

- ____ - Any damages to equipment or components provided by SEQUOYAH ENTERTAINMENT are the sole responsibility of the PURCHASER with the exception of damages caused SEQUOYAH ENTERTAINMENT staff.

- ____ - In the event of circumstances deemed by SEQUOYAH ENTERTAINMENT to present a threat or implied threat of injury, harm or damage to staff or equipment. SEQUOYAH ENTERTAINMENT reserves the right to stop the performance or service. If the Purchaser is able to resolve the threatening situation to the satisfaction of SEQUOYAH ENTERTAINMENT in a reasonable amount of time (MAXIMUM of 15 MINUTES), SEQUOYAH ENTERTAINMENT shall resume performance in accordance with the original terms of the agreement. PURCHASER shall be responsible for PAYMENT in full, regardless if the situation is or is not resolved or if SEQUOYAH ENTERTAINMENT does or does not resume the performance.

- ____ - This contract is not binding until payment is received and the agreement is signed by both SEQUOYAH ENTERTAINMENT and PURCHASER. Any changes must be made in writing and signed by SEQUOYAH ENTERTAINMENT and PURCHASER. Oral agreements are non-binding. If any clause in this agreement is found to be illegal the contract shall remain in force.
